## Chair's Letter

Spring semester is off to a good start following an eventful fall semester. We welcomed five incredible tenure-track faculty and one full-time temporary lecturer. They

replace retired and relocated professors and have both reinforced our curriculum and created additional learning opportunities. It is always fun to welcome new people, and five to the tenure track is unheard of in this tight job market. Read more about the newcomers on *page 4*.

I continue to be amazed by our students' hard work and accomplishments. They were awarded \$77,500 in scholarships for the 2017–18 academic year from the Tennessee Society of CPAs (TSCPA), including two of the coveted \$25,000 King Scholarships. See the complete list of recipients on *page 8*.

Our students are getting internship opportunities earlier than ever in their studies. In order to accommodate this new hiring model, we are hosting our first Leadership Exposé on Thursday, March 1. Participation in leadership conferences

offers students a glimpse at their career paths and opens up windows to internships. This results in more knowledgeable attendees at Meet the Firms in September, our premier recruiting event.

Our Master in Accountancy (M.Acc.) program is up 19 percent, and successful CPA exam results have been pouring in. An Accounting Analytics course was developed and added to the curriculum to accommodate the new business environment. In addition, we revived advanced governmental and external auditing graduate courses. A preview of the new analytics course is on *page 6*.

We are constantly striving to connect to prospective students. In those efforts, we hosted Discover Accounting Day, sponsored by the TSCPA, on Oct. 20. Nearly 150 students from nine middle Tennessee high schools participated in the four-hour seminar. 

It has been a delight to meet our students' employers and connect with current students and graduates. While a college student, I found it very exciting to tour offices and I still feel blessed to make these "field trips."

Here is a summary of **their comments** and my responses:

- *Employers are pleased with our students/graduates and want more of them!*
  - This is great to hear. We are trying to entice more high-achieving students into the Accounting major. Area high schools heavily promote students to pursue STEM (science, technology, engineering, and math) careers. These students often have the same skills and aptitudes of Accounting majors, and we are trying to let them know of the opportunities available in accounting. If you know of a student who may be a good fit for us, please send them to me!
- *Employers love the work ethic of our students.*
  - MTSU students are used to juggling work, family, student organizations, etc., and come ready to work. Our students do not convey a sense of entitlement.
- *Grade point averages from MTSU do not suffer from grade inflation.*
  - Sometimes MTSU GPAs under 3.5 are equivalent to GPAs above 3.5 from other schools. We believe A's are reserved for excellence and are hard to come by. By no means is a B a bad grade.
- *Employers are concerned with the recruiting process and Career and Placement Center at MTSU.*
  - MTSU is aware that improvements need to be made and is hopefully making some meaningful changes to the Career and Placement Center. In the past, the majority of our department's formal recruiting was in the fall semester. With the transition to more year-round recruiting, I plan to monitor the situation more closely.
- *Employers wish more was being done to accommodate students who cannot attend our daytime student organization meetings.*
  - I admit that being in Beta Alpha Psi is probably the single best thing a student can do to further their accounting career, but work and other obligations can keep them from active participation. We have other student groups available and are working on ways of inclusion regarding job and internship opportunities. I send out the position announcements you send me regularly to all of our majors and make them available on our website. I hope to do more for our nontraditional students in the future.

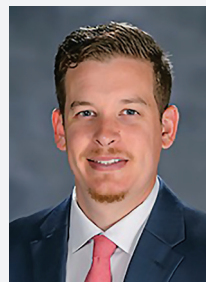

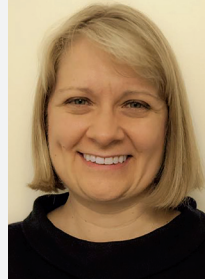

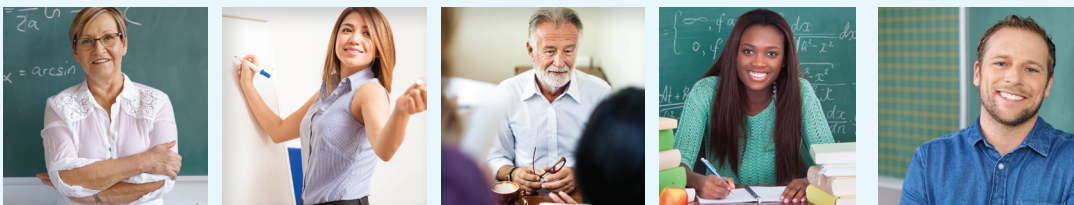

## Accounting Excellence Distinguished Speaker

On Dec. 1, **Mary B. Curtis**, CPA, CISA, Horace Brock Centennial Professor of Accounting at the University of

North Texas, presented a research paper to the MTSU Accounting faculty entitled “What Happens When Formal and Informal Norms Conflict?” Curtis is the past senior editor of the highly rated *Journal of Information Systems*. A prolific researcher, she has over 50 publications in a variety of journals, including *The Accounting*

*Review; Accounting, Organizations and Society; Auditing: A Journal of Practice & Theory; Journal of Information Systems; Journal of Business Ethics; Journal of International Accounting Research; Journal of Accounting Education; Strategic Finance; and The CPA Journal*. Curtis is the Ph.D. program coordinator and an impactful teacher of business ethics, accounting information systems, and IT auditing.

Curtis received the University of Kentucky’s Von Allmen School of Accountancy Ph.D. Program Distinguished Alumni Award in 2014, the American Accounting Association Information System Section’s Outstanding Service Award in 2007 and 2011, and five research paper awards at various conferences and publications in 2005–10.

## New Accounting Analytics Course

The Accounting Analytics course is being offered for the first time this spring as an elective course in the M.Acc. program. The course explores the role of big data and analytics in the accounting profession. Specifically, students study the use of accounting analytics to identify, analyze, and solve accounting and business problems and communicate insights to stakeholders. The course provides students with hands-on experience with a variety

of analytic tools used in the accounting profession, such as Caseware, IDEA, and Tableau. Students study analytics in several different areas of accounting, including internal and external audit, tax, and financial and managerial accounting. ## Student Spotlights

### KAVIN ISMAIL

At night, her mother cleaned the offices at One Nashville Place—the home of Ernst & Young (EY) and National Association of State Boards of Accountancy (NASBA); Ismail often accompanied her mother. One night she met the CFO of NASBA, who told her she should be an accountant. As a result, Ismail researched



accounting. She found it interesting and that it could lead to a lucrative career. After participating in shadow day at the Deloitte IT Hermitage office, she decided she would major in Accounting at MTSU after high school.

Ismail attended summer leadership programs with EY and Deloitte, which led to internships. She has completed five internships—Deloitte IT, Deloitte Audit, HCA Internal Audit, Nashville Electric Service, and Joseph M. Bennie, CPA. Ismail is currently enrolled in the M.Acc. program and serves as a graduate assistant. She will graduate this summer and begin her health care auditing career at Deloitte in the fall. Joshua Beaty grew up in Cleveland, Tennessee and attended Bradley Central High School, where he became interested in pursuing a business career from his business management and computer programming classes. Beaty started MTSU as a Business Administration major. At summer CUSTOMS orientation, he talked to students and advisors and they directed him toward accounting. promising future.

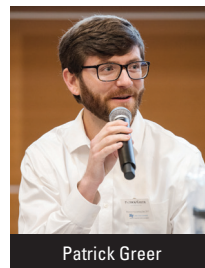
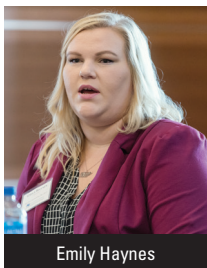
## Discover Accounting Day

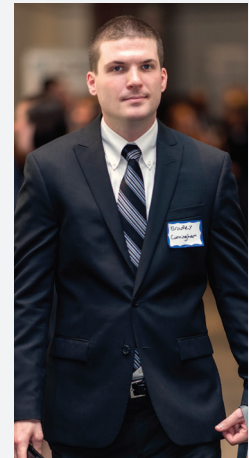
