**A Resolution to impeach Senator Ryan Richards from his position as an At-Large Senator.**

**Whereas:** Ryan Richards has missed two consecutive Senate meetings unexcused,

**Whereas:** Senator Richards has a total of three unexcused absences including September 7<sup>th</sup>, October 19<sup>th</sup>, and November 2<sup>nd</sup>,

**Whereas:** The SGA Senate Bylaws state “Any member who shall miss any three meetings or two consecutive meetings within the same semester shall be subject to impeachment,”

**Whereas:** Ryan Richards has failed to meet the required duties of a Senator, therefore preventing him from effectively representing the student body,

**THEREFORE, LET IT BE RESOLVED BY THE 69TH SGA CONGRESS STUDENT GOVERNMENT ASSOCIATION OF MTSU THAT:**

**Section 1:** Upon passage from the Senate, The Speaker shall appoint a committee of five for the purpose of investigation and that the five senators consist of:


1. Senator Bess Rickman, Internal Affairs

5. Senator Jessica Turri, Internal Affairs


**Section 2:** The results of the committee shall be presented to the Senate.
